Special Report -

John Barends & Julee Docking



Paintings by **John Barends** are always fun to look at. His crisp abstract forms contain words in their design. It isn't obvious what the word is, but it gives the viewer a puzzle to work out while being entertained by the abstract elements. He successfully uses text in his paintings while using carefully executed design to avoid having the words take over, which is a difficult thing to do.

Barends came to art early. He was, "born in the Dutch East Indies where my father was an hydro-

electrical engineer and my grandfather was an art dealer in Holland. Our house was full of paintings, mostly landscapes." He had, "no particular art training in high school in Holland, but was influenced by my grandfather to paint in Caseine and watercolor. Painted a pear tree in the snow (cold) and got first place in the local art show."

During World War II the difficulties he faced goaded him to ever more creative ways to make art. "I was drafted into the Dutch Army and took a correspondence course from the Leiden Art Institute. I moved to Toronto, and studied Oil with Helen De Silaghi. Helen helped with sales and promotions. Since I was living in a small space with no room for a Christmas tree, I created Mobiles with ornaments a la Calder (my hero)." Wartime life became more challenging. "During World War II we were interned for three years." At this point Barends had no art materials. "I used solar with a magnifying glass on a piece of wood, recording our living quarters."

The things that influence his work are, "definitely climate and nature. The 'Group Of Seven' is big in Canada, and is right up my alley, trying to catch the moment." He has a great interest in Plein Air work. "'Whittaker Bayou' done with oil pastel on the spot is one of the many scenes from around




Sarasota," that are examples of images made on location. "When I arrived in Sarasota, the demand for abstracts was big, and I had to invent a style of my own. Words are the ultimate abstracts."

Barends has exhibited in Holland, Canada, California and around Sarasota. Since 1998 he has shown in all of the FLAG locations. He was the Membership Chairman for FLAG 1998-2001. His greatest enthusiasm with FLAG benefits is the website. "You have a fantastic website, and it helped me to get in Sue St. John's book."

Julee Docking works in a variety of media, and her art covers a wide range of interests. Many of her works show a strong interest in landscape. She produces work that treats other subjects as well. Additionally, much of her output is abstract. Nevertheless, all of her art shows her distinct consciousness. Her abstractions are clearly informed my her landscapes, and her other work shows the influence of her abstractions.

Docking's interest in art came early, "I became interested in art in kindergarten with colored paper. No serious training in elementary or high school. I taught myself." Docking went on to study at the



Corcoran School of Art in Washington, D.C. Where her favorite teachers were Robert Laurent and Heinz Warneke. "In the 1960's, Joel Reeves art structure from his MIT course, Maxine Yalovitz for portrait and figure, and Constantine Chatov for oil painting" were other important influences. Her development was supported by others, such as, "an Atlanta dentist took woodcuts instead of a fee. A Wealthy sculptor gave me a job so I could continue my lessons."

Her work was fed by other sources as well, "All the earthly delights—flora and fauna everywhere I lived." Her work is fed by "Plein-air painting with oil pastels." This no doubt has helped her to absorb the beauty and influence of the landscape. Docking draws on many ideas, "any and every subject or idea. It is nice when something I painted is liked, since all are very diverse."

Docking's work "has been exhibited up and down the east coast of the U.S. with FLAG, National Pen Women and WCA." She has found that during her career, "The world of art hasn't changed much—but there's more photography and digital. I would like to see more local representation and support from galleries."

"I joined FLAG in early 1970. I had a leadership position, Chairman for Area III in 1997, after Connie Heller developed lung cancer," she says. Docking, "would like to see the Florida Artists Group keep going –wonderful to have a yearly state show."

Pat Zalisko's work was juried into the Annual All-Florida Exhibition at Ft. Myers' Alliance for the Art. The show opened in June and closes at the end of July. Several of her pieces are currently being exhibited at Raising The Bar, a group exhibition of the art of eight lawyers from the Lee County Bar Association. The exhibition is at the Sidney and Berne Davis Art Center in downtown Ft. Myers. Zalisko is also participating in the Abstraction show at the Center for the Arts of Bonita Springs, which opens on August 2. Last year, one of her paintings took Best Of Show in that annual event. Her work, Flux III-6-1, earned First Place in the Square Show at the Center in May. Zalisko's piece, Elkridge, as part of a traveling exhibition from the Denise Bibro Gallery, NYC, was exhibited until June at the Narrows Art Center, Fall *River, MA, for a group show there.* The exhibition, Petroleum Paradox, which had been juried by ArtPress and Art in America's Eleanor *Heartney*, *earned national press*.

Elridge was singled out and reviewed in South Coast Today by art reporter Don Wilkinson. Also new this summer, Zalisko is now represented by Roan & Black, Saugatuck, MI.

Zalisko will be have a solo exhibition of her art, entitled Material Witness, at the University of South Carolina Gallery, which opens during the second week of September, 2013. She will conduct a gallery talk for faculty and students at the University before the public opening reception. Her work is also being featured in two catalogs set for publication this Fall: Women Unite, predicated upon a juried group exhibition sponsored by the Women's Caucus for Art and the National Museum for Women Arts (D.C.); and Stories We Tell, derived from a smaller exhibition at Phoenix Gallery, NYC, which opens in Sept. 2013. Some of Zalisko's work will also be shown at the Ukrainian Institute of Modern Art, Chicago, this Fall, in a group exhibition

commemorating the 80th anniversary of Holodomor, the Ukrainian holocaust. Lastly, as a result of an exhibition at the von Liebig Center for the Arts in Naples, the curator has selected Zalisko's work to be exhibited from July 25 through November, 2013 at the Physician's Regional Hospital Complex (formerly Cleveland Clinic) in Naples.

Earlier in July, Terrie was notified that one of her pieces, Moonflowers, had been selected for a national juried exhibition, Pinnacle. (Robin Holder, a New York based artist specializing in multi-layered printmaking and collage, was the juror). The exhibition opens at Foster Tanner Gallery on the Florida A & M campus in September 2013. In June, *Terrie participated in several* exhibitions in addition to the FLAG

exhibition at LeMoyne. Her work was selected for To Collaborate or Not to Collaborate at the FSU MoFA featuring members of the museum's Artists' League. (This exhibition was juried by Sandy Shaughnessy, Director of the Division of Cultural Affairs.) Terrie also coordinated (and participated in) Glass at the Walmsley *featuring emerging and* established glass artists from the region. (The Walmsley gallery is a smaller gallery located within the FSU MoFA). She also exhibited in "FLOR 500" at the 621 Gallery. Earlier in the summer, Terrie submitted an exhibition proposal (for the Artists' League of the FSU MoFA) to the Division of Cultural Affairs. Her proposal was accepted, and the Artists' League of the FSU MoFA will exhibit in the 22nd Floor Gallery, at the top of the Capitol, in the fall of 2015. She is delighted to be a new member of FLAG and looks forward to participating and *exhibiting with the group.*
