However, the Museum has stated that the conditions for exhibit are that it must be a juried show with no more than 75 pieces. Either they will jury or we may choose a reputable juror that meets their approval. The board voted (with 2 dissents) to enter into discussions with the Boca Museum to see if we could secure the venue and agreed that this 2005 show would be juried.


We wish **Connie Maass** a fond farewell. She moved to northern climbs in August.
