

From Don:



## SYMPOSIUM REPORT

Our 51st Annual Symposium and Exhibition at the Capitol Gallery was exciting, inspirational and fun. We had about 40 members, smaller than usual but that was due to the distance away from the majority of our members and the time of year. You all missed a good one!

At the Annual Meeting, we elected the following slate of officers: Don Carmichael, President; Bob York, Vice President; Shirley Frank, Treasurer; Eleanor Merritt, Recording Secretary; and Brooke Allison, Corresponding Secretary. Congratulations and best wishes to all of them.

The program started with Peg Richardson's inspirational talk on the *State of Art in the State of Florida*. Were you aware that Florida ranks third in state funding for the arts in the country? It should make us proud of our state. Peg is Director of the Florida Department of State's Division of Cultural Affairs and really informed us on the importance of the arts to the state. She was followed by Lee Modica, Administrator of the Art in State Buildings



Program. The highlight of her talk was the showing of slides of the exciting art used in the buildings ranging from the very traditional to the most avant-guarde. It was great to

see such vitality and variety from Florida artists.

After lunch, we had a delightful excursion to the Mary Brogan Museum of Art and Sciences featuring the Red Grooms Show which was pure fun, but with a satiric look at contemporary society. The museum itself is a joy, colorful and modern.

Our 51st Annual Exhibition had 90 works. It is a good looking show, very well staged by Sandy Shaugnessy in the "penthouse" of the Capitol. The exhibition will be on view until August 11th with pickup at Roger McMullen's on August 18 and 19, noon to 6pm. This year, because of the shuttle charge, there was no entry fee, thus no FlAG Best of Show Award. But, the Elizabeth Morse Genius Memorial Award which is now an ongoing award of \$1000 took its place. This is a one-time-only change. Next year we will have both the FlAG Best of Show and the Genius Award. Congratulations to all the award winners.

Unfortunately, the Capitol does not hang nude painting or drawings. This information was not in

the contract I originally signed, happily it now is in the description of work acceptable. One of our members was asked to replace his work, understandably he was incensed and withdrew his piece and canceled his participation in the Symposium. Following the wishes of the membership at the Annual Meeting, I made a written and telephone protest against this policy to Peg Richardson. I think it was wise and imperative to do this but realistically I don't think it will change the legislators.

A pleasant buffet dinner with remarks on the Chrysler Museum by our juror, William Hennessey, Director of the Chrysler wound up Symposium day.
